Sowers Cemetery Chronology of Events

- 1867 earliest year marked on any grave marker on that of Catherine Caster Hawes Worthington.¹ (This is a modern day marker and not from that period.)
- 1868 First graves on the property immediately north and adjacent to the property later donated by Edmund Sowers. Folklore believed to be unmarked graves of a woman and her daughter of an unknown "tragic" death.²
- 1874-08-14 Edmund Sowers officially donates land for church, school and burial purposes.³ This is the existing SW portion of today's cemetery.
- 1891 SS Conner, the earliest documented owner of the earliest burial property, sells land to Pete and Lidia Faucher.
- 1893 Pete Faucher sells this land to SS (presumably Sevier) Smalley
- 1899-08-09 For \$1, Edmund Sowers donates adjacent land east of the first dedicated burial property to increase the cemetery size.⁴
- 1909-05-13 E.D. Sowers dies at the "extreme age" of 83.5

- 1926-03-02 Otis Brown donates the current day eastern "Otis Brown addition to Sowers Cemetery" land.⁶ Records indicate this section was also known as Otis Brown Memorial Park or primarily Sunset Memorial Park.
- 1934 28 February, DD Brunson and DL Herring purchase the 5.556 acres "Beulahland" property from the Federal Life Insurance Co. for \$300.⁷
- 1934 6 August, earliest known mention of a corporation called Beulahland Memorial Park which purchased the same 5.556 acres from Brunson and Herring for \$10⁸
- 1956 Irving ISD takes over Sowers School District and property donated by Mr. Sowers in 1874 including a portion of the cemetery.
- 1960 old Sowers School destroyed by fire.⁹
- 1961-06-16 Sowers Cemetery Association is formed
- 1962 New chain link fence erected by Cemetery Association.
- 1966-06-13 Oldest recorded minutes remaining from Association archives
- 1966-09 Otis Brown Memorial Park Addition and operating funds transferred to Sowers Cemetery Association¹⁰
- 1973-06-10 State Historical Marker Dedication. The first in the City of Irving.¹¹

- 1980-05 Last organized meeting of the 1960 1970's era Sowers Association held at Mr. and Mrs. Boatwright's home. 12
- 1992 By Laws written that indicate Bobby Crockett, President; CJ Range, VP; Joyce Range, Secretary; Marvin Story, Treasurer¹³
- 2007-05-14 filed and issued Certificate of Formation for Domestic Nonprofit Corporation with the Secretary of State of Texas. Texas tax payer number 32032049077.
- 2012-10-09 Sowers Association and Bob and Pat Crockett are recognized at the Heritage Society's Organizations Recognition event.¹⁴
- 2014-01-13 By-Laws amended
- 2017-08 Cemetery board approves new fence installation by RM Fabrication on south and east sides of cemetery.
- 2017 Fall Irving ISD installs approximately 300' of new fence on west side.
- 2018-06-09 150th Anniversary event held on the cemetery grounds with Mayor and State Representative in attendance.
